WE PROTECTED AN ADDITIONAL 27 ACRES, BRINGING THE TOTAL TO 6,917 ACRES CONSERVED. TO RESTORE CULTURALLY AND ECOLOGICALLY SIGNIFICANT SPECIES, OVER 100 CAMAS BULBS AND RIVERBANK LUPINE SEEDS WERE PLANTED IN PARTNERSHIP WITH THE SQUAXIN ISLAND TRIBE AT BAYSHORE PRESERVE.
